BCM Webinars Series by AAIS

Together with experts from member companies and knowledge partners, the AAIS webinar series on Business Continuity Management (BCM) is a platform for the aerospace industry to share best practices and engage in mutually beneficial exchanges and learning.

The inaugural webinar entitled, "Leadership for Business Continuity in the Covid-19 Pandemic", was held on 7 April. It featured AAIS Vice President and General Manager of Pratt & Whitney Turbine Overhaul Services, Mr Richard Wong, who presented a comprehensive overview of strategies and mechanisms that can be put in place to anticipate and plan for contingencies.

The second session on 9 April featured Mr Maxwell Davis, Enterprise Risk Manager Asia-Pacific & Data Protection Officer for Singapore at Rolls-Royce. Titled, "Ensuring Business Continuity in Operations", the session covered approaches and considerations for a BCP including a review of key processes, reports, and control mechanisms to facilitate smooth operations in times of crisis.

AAIS COVID-19 Business Impact Survey

Led by the Aerospace COVID-19 Taskforce (ACT), AAIS launched an online survey on 26 March 2020 to better understand the business and workplace challenges, as well as needs of members amidst the COVID-19 pandemic. A series of online industry sharing sessions were also held on 31 March, 1 and 2 April, where members shared their experiences and responses to the outbreak.

The inputs and feedback will guide AAIS in formulating plans and actions to better support the aerospace community. Findings from the survey have also been reported to the Singapore Economic Development Board and Enterprise Singapore. In this rapidly-moving environment, we continue to invite aerospace companies, especially SMEs, to provide inputs on your business and workplace concerns and ways we can collectively address these.

Budget 2020: Support for Businesses

Deputy Prime Minister and Minister for Finance Heng Swee Keat delivered a Ministerial Statement in Parliament on 6 April 2020 on Additional Support Measures in response to the COVID-19 Elevated Safe Distancing Measures.

Under the "Solidarity Budget", the Government will devote \$4 billion to support businesses and workers through COVID-19. The key measures announced were:

- **Enhanced Job Support Scheme** Raised wage subsidy for all firms to 75% of gross monthly wages, for the first \$4,600 of wages paid in April 2020, for each local employee. The first payout will be brought forward from May to April 2020.

- Waiver of monthly Foreign Worker Levy For the month of April, employers will be provided with a Foreign Worker Levy rebate of \$750 for each work permit or S-pass holder, based on previous levies paid in 2020, by as early as 21 April 2020.

- **Further support on Rental Costs** The Minister for Law will introduce a Bill to let businesses and individuals defer rent payment, loan repayment, or work completion, for a period. The Bill would ensure that property owners pass on Property Tax Rebate in full, to tenants. The Government will increase rental waiver for industrial, office and agricultural tenants of government agencies to 1 month, up from the 0.5 month's rental waiver.

- Enhanced Financing Support The government has increased risk share of loans made under the Temporary Bridging Loan Programme, Enterprise Financing Scheme SME Working Capital Loan and Enterprise Financing Scheme Trade Loan from 80% to 90% for loans initiated from 8 April 2020 until 31 March 2021.
