

Extension of Circuit Breaker

In an address to the nation on 21 April, PM Lee Hsien Loong gave an update of the COVID-19 situation and announced new measures to further curb community spreading including an extension of the circuit breaker period till 1 June 2020 (inclusive).

The Multi-Ministry Taskforce also announced that fewer businesses will be permitted to operate during the Circuit Breaker to reduce the number of workers who have to physically go to work. Businesses which had earlier received approvals by MTI to operate during the original Circuit Breaker period from 7 April 2020 to 4 May 2020 can continue doing so until 1 June 2020. MTI will notify businesses that have to suspend operations.

Extended Support Measures (21 Apr)

The Government also announced continued support for businesses through the extended circuit breaker period, building on the measures introduced in the Unity, Resilience, and Solidarity Budgets. The key measures announced were:

- Jobs Support Scheme at 75% for all sectors for May The 75% JSS wage support will be extended across all sectors in the month of May 2020. The payout will be disbursed by end-May 2020 for employers on PayNow or having existing GIRO arrangements with IRAS. Do sign up for PayNow Corporate to receive payouts faster.
- **JSS to cover shareholder-directors** The JSS will be extended to cover wages of shareholders and directors of a company, for the wages of shareholder-directors with Assessable Income of \$100,000 or less for Year of Assessment 2019.
- Foreign Worker Levy (FWL) Waiver and Rebate extended by 1 month The FWL waiver and FWL rebate will be extended by one month, to ease labour costs of firms that employ foreign workers in this period.


