# **AAIS Statement on COVID-19**

AAIS will continue to monitor the evolution of COVID-19 closely.

We are confident that the coordinated and swift response by the Singapore government, led by the multi ministry task force and public health institutions, will limit the spread of the virus. At the same time, we must all play our part. AAIS strongly recommends that businesses comply with the control measures, for the health and safety of all. The situation has also inevitably impacted daily operations and staff deployment for many in the industry. AAIS stands together with the aerospace community at this challenging time. We will be calling members in the coming weeks to gather your feedback and discuss any concerns you may have. This may include facilitating skills upgrading and other training activities for your staff in the short term. The air transport sector has weathered difficult and stormy periods in the past, such as the SARS and aftermath of 9-11. # **AAIS Partners Starburst Accelerator**

AAIS has signed a Memorandum of Understanding with global aerospace start-up accelerator, Starburst, to collaborate on the Singapore Aviation Tech Accelerator. The programme aims to develop start-up enterprises based on their potential to provide solutions to Air Transport problem statements in areas such as Air Traffic Management, Passenger Experience, Cyber Security, Mobility, Connectivity, Data Analytics and Artificial Intelligence. The signing ceremony took place on 12 February 2020 on the sidelines of the Singapore Airshow.

## **Budget 2020: Measures for Businesses**

In the 2020 Budget Statement delivered on 18 February 2020, Deputy Prime Minister and Finance Minister Heng Swee Keat shared about the measures that the Government will put in place to support businesses through the uncertainties in the global environment while preparing them to capture the opportunities in the future. Initiatives announced include:

- A S\$4 billion stabilisation and support package: To help enterprises and workers tide through the current economic uncertainty, this package will provide cash flow support and assistance in retaining and retraining workers.
- Enhanced tax rebates and loan offerings: Companies will be granted a rebate of 25% tax payable, capped at S\$15,000 for the year of assessment 2020. The maximum loan quantum under the Enterprise Financing Scheme will also be raised to \$600,000 and the Government will increase its risk-share on these loans to 70%.
