Note:

The IHCI Enabler Programme qualifies for further support under:

- SSG's SkillsFuture Enterprise Credit (SFEC) - S\$10,000 credit to cover up to 90% of out-of-pocket
- SBF's Rising in Support of Enterprises (RISE) - \$500 cost offset for companies with paid-up capital <\$5mn

Eligible companies must pay the applicable fees stated in the above table upfront, and then claim SFEC/RISE rebates post-completion.

Each Singapore-registered company, as defined by its Unique Entity Number (UEN), will be eligible to tap onto the WSG subsidy stated in the table above only once. Companies interested in attending the programme more than once are most welcomed to do so at the unsubsidised fee.
