Rental Relief Framework (COVID-19 Act)

The COVID-19 (Temporary Measures) (Amendment) Act that was passed in Parliament on 5 June 2020 provides a rental relief framework for Small and Medium Enterprises (SMEs). The framework aims to help affected SMEs recover from the impact of COVID-19, by providing mandated co-sharing of rental obligations between the Government, landlords and tenants. New rental relief provisions will come into force by end-July 2020. Under Part 2 of the Act, enhanced relief is also available for businesses, organisations and individuals, who are unable to fulfil their contractual obligations because of COVID-19.
