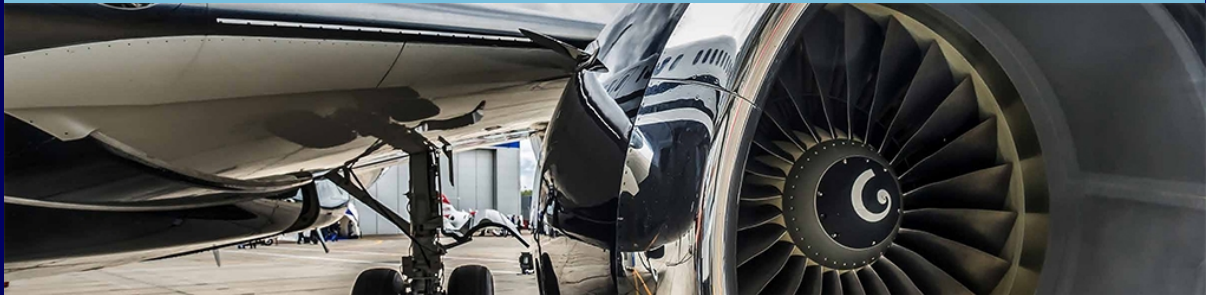

## Re-Align Framework to Renegotiate Contracts for Businesses Significantly Impacted by COVID-19

The Ministry of Law (MinLaw) has introduced a new Re-Align Framework targeted at small businesses that have been significantly impacted by COVID-19, and need to review their contractual obligations.

Broadly, the framework will provide parties with a basis to renegotiate certain types of contracts to come to a mutual agreement. If parties are unable to agree, the contract may be terminated within provided parameters. Businesses will remain liable for outstanding debts and obligations, but will not need to pay early termination penalties.

The framework will commence on **15 January 2021**, for a period of 6 weeks (until and including 26 February 2021).

## Over \$1 billion in 2020 Wage Credit Scheme payouts

The Ministry of Finance and the Inland Revenue Authority of Singapore remind employers to make the full CPF contributions for their employees by **14 January 2021**, in order to receive the next tranche of Wage Credit Scheme payouts in March 2021.

The next tranche of payouts in March 2021 are for qualifying wage increases in 2020. The payouts will be credited directly to eligible employers' registered bank accounts through PayNow Corporate or GIRO.

## Webinar: Building Facade Inspection Using UAS

More than 200 participants attended an interactive virtual Workshop on TR 78 : 2020 - Building facade inspection using Unmanned Aircraft Systems (UAS) on 25 November 2020. The event was jointly organised by AAIS, Singapore Manufacturing Federation – Standards Development Organisation, Singapore Standards Council and Enterprise Singapore.

TR78 provides a set of non-exhaustive specifications for the use of UAS to conduct inspection of existing building facades. It covers the phases starting from preparation, stakeholder approvals, execution and up to post-flight data processing and report generation.

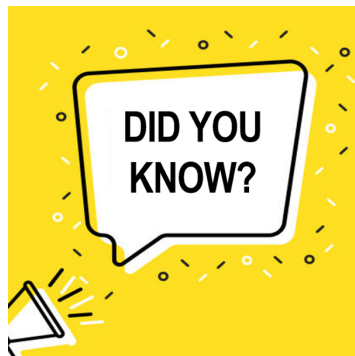
## Certified Quality Engineer for Aerospace (CQEA)
