Phase 2 (Heightened Alert) - COVID-19 Safe Management Measures for workplaces

The Multi-Ministry Taskforce announced on 14 May 2021 the further tightening of Safe Management Measures (SMMs) to reduce the risk of community spread. From **16 May 2021** to **13 June 2021** (both dates inclusive), **Work-from-home (WFH)** will be the **default at workplaces**.

Further Tightening of Safe Management Measures (SMMs)

With effect from 16 May to 13 Jun 2021 (both dates inclusive)



Employers must exercise heightened vigilance at the workplace.

Work from home as a default.

- · No cross deployment of staff.
- · Social gatherings at the workplace are not allowed.
- Employers should continue to stagger start times of employees who need to return to the workplace and implement flexible working hours.



Dining in is not permitted at all F&B establishments.

• F&B establishments can only operate for takeaway and / or delivery.



Affected businesses will receive 50% Jobs Support Scheme (JSS) support during this period.

One month of rental waiver for hawker stall and coffeeshop tenants of Government agencies.



Indoor activities that require masks to be taken off are not permitted.

- Establishments, including personal care and wellness services, can continue to operate, but activities that require unmasking are not allowed (e.g. facials, sauna).
- · Medical services which require the removal of masks can continue to operate.



Tighter capacity limits for MICE events and live performances.

- · Events can have up to 100 pax with Pre-Event Testing (PET) and up to 50 pax without PET.
- · No singing and no wind instruments for live performances.
- · Masks have to be worn at all times.



Occupancy limit for malls, showrooms and large standalone stores will be one person per 16 sqm of Gross Floor Area (GFA).

 Retail establishments should cancel all events, promotions or sales that will generate crowds at their premises.



Operating capacity limit for attractions, cruises and museums will be reduced from 50% to 25%.

 The maximum capacity for shows, both indoor and outdoor, will be capped at 100 pax with PET and up to 50 pax without PET.

National Wages Council (NWC) 2020/2021 Addendum

On 14 May 2021, the NWC announced that its latest guidelines on wage and employment-related issues will be extended until November 2021 as they "remain relevant" amid an uneven economic recovery ahead.

Employers to Continue to Minimise Retrenchments and Take Steps to Emerge Stronger

All employers should re-evaluate their business situation and how the NWC guidelines would apply to them.



Employers that have done well and have good business prospects:

- · Reward employees fairly through variable payments.
- · Bring forward hiring plans.
- · Grant built-in basic wage increases.

Employers that are experiencing business recovery:

- Restore wage cuts implemented earlier, or roll back other cost-saving measures (such as reductions in allowances and commissions, shorter work week, temporary lay-offs, and no-pay leave), in tandem with business recovery and in a timely manner.
- Employers who have reduced basic wages as an exceptional measure to save jobs should restore basic wages first, followed by the variable wage components i.e. Monthly Variable Component (MVC) and Annual Variable Component (AVC).
- When determining the AVC payment, employers should continue to consider the company's and individual's performance.

3 Employers that continue to be adversely impacted by COVID-19:

- Take maximum advantage of Government support measures to accelerate business and workforce transformation.
- · Retain employees through appropriate cost-saving measures.
- Retrain and redeploy employees in affected business units to new jobs within the company.


