## Highlights

### MOF Announces Additional Support Measures for Businesses - 21 June 2022


DPM and Minister for Finance Lawrence Wong yesterday announced a S\$1.5 billion support package to provide targeted relief for the lower-income and vulnerable groups. The package will also extend more help for local companies in their enterprise and workforce transformation.

Newly announced support measures that may be relevant for aerospace companies are:


- Increased support for the 2022 Progressive Wage Credit Scheme (PWCS) to co-fund the wage increases of lower-wage workers.
- Extension of Jobs Growth Incentive (JGI) for businesses that employ vulnerable workers, including mature jobseekers who have not been working for at least six months, as well as persons with disabilities or ex-offenders.
- Enhancement of the Enterprise Financing Scheme – Trade Loan, and SME Working Capital Loan – to support local enterprises with cashflow concerns.

**\$1.5 billion Support Package**  
to Provide Targeted Relief for Lower-Income Households and Vulnerable Groups



**Energy Efficiency Grant**  
For SMEs in Food Services, Food Manufacturing, and Retail sectors; up to 70% support to adopt energy-efficient equipment in pre-approved categories




**Enterprise Financing Scheme - Trade Loan**  
Maximum loan quantum increased to \$10m from 1 Jul 2022 to 31 Mar 2023; extended 70% risk-share during this period



**Enterprise Financing Scheme - SME Working Capital Loan**  
Maximum loan quantum increased to \$500k from 1 Oct 2022 to 31 Mar 2023 after the Temporary Bridging Loan Programme expires on 30 Sep 2022


#### Supporting Workers

**\$1.5 billion Support Package**  
to Provide Targeted Relief for Lower-Income Households and Vulnerable Groups



**Progressive Wage Credit Scheme**  
Increase in Government's co-funding for eligible wage increases in 2022 to help lower-wage workers:

- From 50% to 75% for wages up to \$2,500 (first tier)
- From 30% to 45% for wages above \$2,500 up to \$3,000 (second tier)



**Jobs Growth Incentive (JGI)**  
JGI will be extended for another 6 months to Mar 2023 to sustain support for employers of vulnerable workers. More details will be announced in Sep 2022.

### How COVID and Conflict in Ukraine has affected Aircraft Leasing

Aviation is on the path of recovery from the effects of the COVID-19 pandemic. Leased aircraft now account for an estimated 60 percent of new passenger jet deliveries. This has shot up from approximately 45 percent before the pandemic. This growth may seem somewhat surprising, considering that during the pandemic many airlines sought to defer lease rentals or even defaulted on payments.

Even before we have bid goodbye to the pandemic, a new crisis has arisen in the form of the Russia-Ukraine conflict. More than 500 western-made leased aircraft were affected by sanctions against Russia. What is happening to these aircraft, how are lessors responding and what legal issues have arisen?


To shed some light on developments, we are delighted to have Rob Morris of Ascend by Cirium, and Rajaram Ramiah of RHTLaw Asia to share their take on how aircraft leasing weathered the pandemic and is dealing with the fallout from the war in Europe.

## SAQG Workshop: Changes in EASA Part 145

This year, the European Union (EU) and the European Union Aviation Safety Agency (EASA) introduced changes to the Part 145 requirements, through Reg. (EU) 2021/700 (applicable since May 2022) and Reg. (EU) 2021/1963 (in force and applicable from 2 December 2022). While only minor changes were introduced to Reg (EU) 2021/700, major and significant changes have been introduced to Reg. (EU) 2021/1963.

The Singapore Aerospace Quality Group (SAQG) has specially invited Mr Luigi Preti, Maintenance Organization Expert & EASA International Officer in Singapore, to conduct an upcoming workshop addressing these changes. The intent of the workshop is to provide the Singapore aerospace industry with relevant updates to facilitate the understanding and the implementation of the above-mentioned Part 145 requirements, inclusive of the related AMC/GMs.

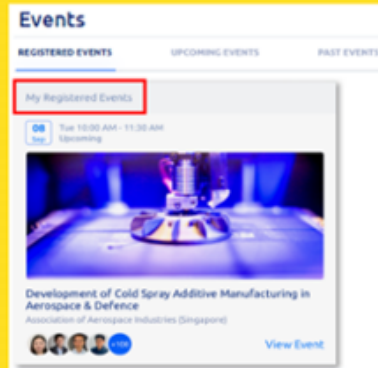
